CARDIO WARRANTY

Notes:

- 1 All units retain the warranty coverage that was specified for the year the product was purchased.
- 2 Warranty coverage is for the original purchaser or any person receiving the product as a gift, prior to use, from the original purchaser.
- 3 All terms of the unit's warranty are void if the product is moved beyond the continental borders of the United States of America (excluding Alaska, Hawaii and Canada) and are then subject to the terms provided by that country's local authorized Life Fitness
- 4 LF Consumer units sold by dealers should have their warranty effectivity date reset to point of sale up to 1 year from dealer's original purchase date. This includes new product and floor models.
- 5 Consumer product placed in a commercial setting nullifies the warranty. Contact CSS Finance to void the warranty in the system.
- 6 If a NEW commercial unit is placed in a private residence (home), the unit is covered by that product category's consumer warranty. All Warranty Parts Orders MUST be created using Manager Override Service Type after commercial warranty expiration (as applicable to the comparable consumer product warranty.)
- 7 Platinum Consumer console has 3 year warranty coverage. All Service during final (third) year MUST be created using Manager Override Service Type.
- 8 Group Training:
 - a. Commercial Labor Coverage = 3 Months
 - b. Consumer Labor Coverage = 12 Months. Service must be created using Manager Override Service Type.
- 9 Consumer Treads:
 - a. For T3 - T7 Series motors, units that were shipped prior to August 1st, 2004, the motor has a 5 year warranty and 15 year thereafter.
 - b. For T9 Series motors units that were shipped prior to August 1st, 2004, the motor has a 15 year warranty.
- 10 Class Product:
 - a. Class A Cardio product receives NEW product warranty
 - b. Class B Cardio product receives 90 day bumper to bumper warranty
 - c. Class X product receives NO product warranty and is sold "as is"
- 11 Cybex Console:
 - a. Console-Touch Screen (MechSpecial) receives 36 months.
 - b. E3 or GoTouch Console (Monitor) receives 24 months
- 12 Wear Parts:
 - a. Cybex : Wear parts defined as Pedal straps, seats, grips. Tread wear parts include Walking Belts and Decks. Cosmetic parts include Power cord and Inlets, Headphone Jack.
 - b. Scifit: Wear parts for cardio defined as Upholstery, Rubber Grips, Foot Pads, Battery, Contact HR Grips, Pedals. Tread wear parts include Walking Belts and Decks.

STRENGTH WARRANTY

Notes:

- 1 The published labor warranty for commercial strength is 30 DAYS OUT OF BOX. However, internally, warranty contracts will cover labor for 90 days.
- 2 There is no cosmetic or labor warranty coverage on any Consumer Strength product. 30 day Out of Box period applies.
- 3 For Pro Series (9000) Strength units that were shipped prior to 1996, the frame has a lifetime warranty.
- 4 Class A or B Strength product is sold with NO warranty coverage.
- 5 Strength Accessories are non-serialized and replaced via FG warranty replacement after verifying original order installation date.

Exclusions: The above warranty does not cover damage or failure due to any of the following: a. Abuse, misuse, vandalism, theft, neglect, use of parts or supplies that do not meet the manufacturer's specifications or failure to follow maintenance procedures described in the Operating Guide for the equipment; b. Fire, explosion, flood, lightening, water exposure, corrosion, discoloration of paint or plastic, rust, adverse environmental conditions, or any other Acts of God; c. Fluctuations in the building power supply, failure to provide a power supply, or operating an environment that does not conform to the manufacturer's specifications; d. Repair, service, adjustment, tampering or modification of the equipment by anyone other than Life Fitness authorized service personnel; e. Negligence or acts or omissions of Customer or any third party (excluding a Life Fitness certified service provider); or f. any other cause beyond Life Fitness' direct control.
